Chapter 1—General Rules**

PROPOSED AMENDMENT

20 CSR 2235-1.020 Fees. The State Committee of Psychologists is amending section (1).

PURPOSE: The rule is being amended to add a restoration of license fee and the word fee is being removed from each of the items listed due to redundancy.

(1) The following fees are established for the State Committee of Psychologists and are payable to the State Committee of Psychologists:

(A) Application for Provisional Licensure or Application for Temporary Licensure or Application for Licensure <i>[Fee]</i>	\$150.00
(B) Oral Examination <i>[Fee]</i>	\$ 50.00
(C) Jurisprudence Examination <i>[Fee]</i>	\$ 50.00
(D) Reexamination <i>[Fee]</i> —	
1. Oral Examination <i>[Fee]</i>	\$ 50.00
2. Jurisprudence Examination <i>[Fee]</i>	\$ 50.00
(E) Biennial Renewal <i>[Fee]</i>	\$300.00
(F) Delinquency <i>[Fee]</i> (effective April 1 after each renewal period, in addition to the Renewal <i>[Fee]</i>)	\$150.00
(G) Inactive License <i>[Fee]</i>	\$100.00
(H) Reactivation <i>[Fee]</i>	\$200.00
(I) Restoration	\$150.00
[(I)] (J) Licensure Verification/Transfer of Score to Other States <i>[Fee]</i>	\$ 25.00
[(J)] (K) Replacement of Wall-Hanging License <i>[Fee]</i>	\$ 25.00

PUBLIC COST: This proposed amendment will not cost state agencies or political subdivisions more than \$500 in the aggregate.

PRIVATE COST: This proposed amendment will save private entities approximately three hundred dollars (\$300) to four hundred fifty dollars (\$450) annually for the life of the rule. It is anticipated that the costs will recur for the life of the rule, may vary with inflation, and are expected to increase at the rate projected by the Legislative Oversight Committee.
